## ENTRY TERMS AND CONDITIONS:

- The 2022 Elite Summer Sale is open to:
  - Registered White Suffolk studs who are members of the Australian White Suffolk Association Incorporated;
  - Registered Suffolk studs who are members of the Suffolk Sheep Society of Australia (ASSBA); and
  - Registered Suffolk studs who are members of the Australian Suffolk Association (ASA).
- Vendors must nominate the number of ram lambs, ewe lambs, semen and/or embryo packages at time of entry on the online entry form and the Vendor declaration must be completed by the Vendor or his/her authorised agent. The Vendor submitting the entry is responsible that the statements on the entry form are true and correct. All nominations/entries are subject to the rules and regulation of the Committee.
- An entry fee of **\$77.00 per ram, \$55.00 per ewe, \$55.00 per semen or embryo package** (GST inclusive) is applicable and payable to the Elite Show & Sale Committee.
- A vendor may enter up to five (5) lots/entries in the sale that can consist of rams, ewes, semen packages or embryo packages. There is a limit of a maximum of 2 rams only, however ewes, semen package and embryo packages have no maximum limit provided the total lots for any one vendor does not exceed five.
- All rams/ewes entered in the Sale must be the bona-fide property of the Vendor and must be eligible for registration with the relevant breed society. Vendors must have full marketing rights of any ram in which a semen package will be offered.
- Ram lambs and ewe lambs offered must be born on or after 1<sup>st</sup> April 2021. There is no age restriction on semen packages and embryo packages offered.
- The number of doses per semen package is at the vendor's discretion. Embryo packages must include at least 3 embryos, the number to be at the discretion of the vendor.
- Vendors are reminded of their responsibility to ensure that all rams and ewes offered for sale are structurally and physically sound and meet individual breed standards.
- All vendors **must** provide National Vendor Declaration (NVD) and National Sheep Health Statement by 21<sup>st</sup> January.
- All animals must be from an Ovine Brucellosis accredited flock and are to be either in the MAP or Faecal or Abattoir tested or Vaccinated to be accepted in the Sale. The Committee reserves the right to restrict entries if deemed necessary and to refuse any entry that does not meet the biosecurity or health standards of the Sale. It is highly recommended that Sale sheep are Hypotrichosis tested.
- Following nomination, vendors must provide individual lot data including lot number, lot name (stud prefix and eartag), date of birth, link to pedigree on Lambplan or pedigree information, photographs and/or videos (must be YouTube link) for all lots nominated for sale. - The Committee shall have the right to determine the order, manner, and management of the sale.
- The Committee in no way warrants the condition, quality or performance of any lots offered for sale, and the vendor agrees to indemnify the Elite Committee, Australian White Suffolk Association Inc, Suffolk Sheep Society of Australia (ASSBA) and the Australian Suffolk Association (ASA) and keep them indemnified in respect of any claim that may be made by any person in respect of condition, quality, performance or state of health of the animals entered in the sale.
- All lots sold will be subject to 7% agent commission with an additional 1% commission payable to the Elite Committee.
- All vendors will be invoiced for entry fees after submission of sale nominations. Entries will only be included in the Sale provided entry fees are paid in full prior to the Sale date.
- A refund of entry fees will be allowed for any withdrawal of entries prior to the closing date for entries (17 December). Refund of entry fees for withdrawal of entries after the closing date can be submitted in writing to the Secretary and will be made at the discretion of the Committee. The Committee's decision will be final.
- Closing date for entries is strictly 9:00am, Friday 17<sup>th</sup> December 2021.** No late entries will be permitted.

## VENDOR REQUIREMENTS FOR AUCTIONSPLUS:

- **All vendors must provide information on individual rams / ewes or semen / embryo packages to Nick Farley (Nutrien) direct by Friday, 21<sup>st</sup> January 2022.**

It is important that the below information is provided by the deadline to ensure your lots have good exposure and the sale can be promoted adequately in the lead up to the sale day.

To assist, vendors will be emailed with a template spreadsheet in which they can record their detail in, save and then send the spreadsheet to AuctionsPlus.

The following provides an outline of the information we think would be beneficial to include:

### For all rams / ewes:

- Lot Number
- Lot Name (Animal Stud Prefix and 6-digit Eartag number)
- Link to pedigree / ASBV's on Sheep Genetics, or for those not in Sheep Genetics information on the Sire, Dam and Sire of Dam to be included in the Comments/Description.
- Video (must be provided as a YouTube video link) and/or photographs of animal. This is at the vendor's discretion, it is strongly encouraged that a 1-minute video is provided at a minimum).
- Comments / description for each animal, maximum 50 words

### For semen / embryo packages:

- Lot Number
  - Lot Name (Animal Stud Prefix, 6 digit eartag number and number of doses/embryos in package)
  - Link to pedigree / ASBV's on Sheep Genetics, or for those not in Sheep Genetics information on the Sire, Dam and Sire of Dam to be included in the Comments/Description.
  - Comments / description, maximum 50 words, that declares the number of doses included in the semen package OR the number of embryos included in the embryo package (at least 3).
- **How to find get the Sheep Genetics link for your animal:** Find your animal on Sheep Genetics / Lamplan search and click on the animal so that it loads the pedigree and ASBVs. Click on the website address so that it is highlighted, right click and select "Copy Link" – this is the link you need. You can then paste this into a spreadsheet with your lot information or into an email to AuctionsPlus.
  - **YouTube link for videos:** It is a requirement of AuctionsPlus that all videos are uploaded to YouTube and the YouTube link sent to Nutrien direct, rather than the video itself.   - Changes or additions to any lot information can be made up until sale date by email AuctionsPlus direct.

## AUCTION TERMS & CONDITIONS:

1. The Sale will be conducted as a simultaneous sale (Helmsman style) on AuctionsPlus under the AuctionsPlus User Agreement and Sale Terms. These can be referenced at <https://auctionsplus.com.au/auctionsplus/operating-conditions>
2. The minimum Reserve Price and bidding increments will be set by the Elite Committee.
3. The Sale will run for 30 minutes with additional time following dependent on bids/activity. The closure of the sale will be at the discretion of AuctionsPlus, selling agents and the Elite Committee.
4. Buyers are encouraged to be aware of the restrictions relevant to their location in regard to OJD management and sheep movements. It is the buyer's responsibility to ensure they can take delivery.
5. All new registered AuctionsPlus buyers are required to complete Buyer Induction Training prior to bidding. AuctionsPlus recommends that all intending bidders complete their registration and training 24 hours prior to the Auction.
